WHEREAS, the Board is currently comprised of seven (7) members, consisting of the following:

WHEREAS, the Delaware-Union Educational Service Center and the Franklin County Educational Service Center merged, effective January 1, 2009, to form the Educational Service Center of Central Ohio ("ESC of Central Ohio"); and

WHEREAS, during 2009, two members of the Delaware-Union Educational Service Center will continue as members of the Governing Board of the ESC of Central Ohio, as part of the transition plan for the merger; and

WHEREAS, beginning in 2010, only one (1) representative of the ESC of Central Ohio is guaranteed to be from the area served by the Delaware Area Career Center; and

WHEREAS, in order to better serve the students of the Delaware Area Career Center, the Board desires equal representation of its member districts, and to be composed of members who reside in the area served by the Delaware Area Career Center.

THEREFORE, BE IT RESOLVED that the Board approves a change and reduction in its composition, from seven (7) to five (5) members, as follows, effective January 1, 2010:

- one (1) member from the ESC of Central Ohio;
- one (1) member from the Delaware City School District;
- one (1) member from the Buckeye Valley Local School District;
- one (1) member from the Big Walnut Local School District;
- one (1) member from the Olentangy Local School District;

BE IT FURTHER RESOLVED that the Board authorizes its members, the Superintendent and the Treasurer to take the necessary steps to fulfill the procedural requirements in achieving the change and reduction in composition.
